# Why self-government now?

- Ratifying the Final Self-Government Agreement negotiated over the last 17 years will fulfill the promise of having self-government as set out in the Land Claim.
- We keep the Rights we have under the Land Claim Agreement and also the Rights some of us have as registered Indians under the Indian Act.
- If ratified, our Self-Government, as a "government within the constitutional framework of Canada," will be in a position to protect our Inherent Rights advocating directly to other Canadian governments.

# What are we now?

- We are not an "Indian Act Band" or "First Nation" in Norman Wells.
- We are not governed by federal Acts that apply to First Nations, e.g. the First Nations Financial Transparency Act. We have never received federal funding based on per capita to operate like a First Nation under the Indian Act.
- We are a Canada Not-for-Profit Corporations Act corporation governed by that federal Act and its Regulations, no different from any other federally incorporated not-for-profit corporation governed by that Act and its Regulations that you or I could incorporate.
- Our funding is what we can get through contribution agreements with Canada and the GNWT.

# Can members that have been adopted into TGG Inc. Vote on Self-Government?

- Yes; if their names are on the Official Voters List.
- This is because the Official Voters List is based on the most current list of Sahtu Dene and Metis participants enrolled with TGG Inc. as their Land Corporation under Chapter 4 of the Land Claim Agreement.
- Who prepares that enrolment list? The Sahtu Enrolment Board.

- The Sahtu Enrolment Board is not controlled by TGG Inc.
- The Sahtu Enrolment Board is an independent Board set up by the Land Claim Agreement specifically to decide who are and are not Sahtu Dene or Metis entitled to be enrolled as a participant under the Land Claim Agreement.
- Challenges to the Enrolment Board's decisions go to the Supreme Court of the NWT.

- When you became participants under the Land Claim Agreement you, or your parents, had the right to choose which Sahtu community to affiliate with and you, or your parents, chose Norman Wells.
- No matter where you live in this world you are Sahtu Dene and Metis of Norman Wells – the Tłegohłį Got'įnę.
- Your self-government, the Tłegohłį Got'įnę Government, needs to be based in Norman Wells, in the heart of your ancestors' traditional territories, to directly represent you to governments and to Industry in the Sahtu.
- Just as there is no distinction if you are adopted in or blood related, there is no "northern" or "southern" distinction.

## What is a Self-Government?

- The self-government agreement is an add-on to the Rights you have under the Land Claim Agreement. To Land Rights (Inherent and Treaty) it adds recognition of your Inherent Right of self-government.
  - In addition to being participants under the Land Claim Agreement you are Tłegohłį Got'įnę Government Citizens under the FSGA.
- Your self-government has the right to make your own laws for the Tłegohłį Got'inę, laws that will be recognized by other Canadian governments, Industry and the Courts.
- Your self-government will be a "government within the constitutional framework of Canada", a government to represent you to Canada, GNWT and Industry.
- The Land Claim Agreement was a big step forward recognizing and protecting, in the 1990's, your Land Rights, the FSGA is the next step forward recognizing your Inherent Right to self-government.

# What is the difference between TGG Inc. and TGG (the self-government)?

# What is Core Funding from Canada?

- If you vote yes to ratify the Final Self Government Agreement and Constitution, Canada will be obligated to fund your self government in the minimum amount of \$4.6 million every year.
- There is no "renegotiation" or need to "re-apply". We will receive a base of \$4.6 million every year. This funding arrangement will be reviewed with Canada every 5 to 7 years to adjust for inflation.

#### **On-Going Governance and Administration Funding**



Funding for governance and administration functions includes **base** and **incremental** costs of self-government. The amount of funding is developed collaboratively within the Fiscal Working Group according to Canada's Collaborative Self-Government Fiscal Policy.

- Base costs are associated with governance activities required regardless of population, geographic location or other circumstances.
- Incremental costs are associated with activities that are expected to increase as a result of population growth, program responsibilities of the government, total revenues, and purchases.



- Governance and Administration functions include:
- Executive and legislative decision-making;
- Intergovernmental and legal affairs;
- Centralized administration and policy development; and
- Finance and corporate services.



Ongoing Governance and Administration funding is transferred to groups on an annual basis beginning on effective date.

## This is very different from what we have today as a Not-for-Profit Corporation

- Currently, TGG Inc's day-to-day operations are paid for by administrative fees from contribution agreements with the GNWT and Canada, a similar agreement with the Norman Wells Financial Corporation that provides for the delivery of Chapter II Land Claim programs, topped up by our own money.
- Excluding the funds we receive under contribution agreements from Canada for self-government negotiations, we currently receive less than \$1.5 million from our current contribution agreements.
- Our self-government negotiation funding ends on March 31, 2025 (Ratification Day). If the FSGA is not ratified there will be no more self-government funding available.

## How will your Self-Government get started?

- If you ratify the FSGA and Constitution on March 31, 2025, there will be a 1-year period to transition from a not-for-profit corporation to a self-government.
  - During this 1-year transition we will, along with other things, create a basic set of laws.
  - These laws will be a starting point enabling the Tłegohłį Got'įnę Government to begin operations on the Effective Date (April 1, 2026).
  - Once the Tłegohłį Got'įnę Government starts operating, if those basic set of laws need amending, they can be amended to better reflect how you want your government to operate.

# Examples of a Basic Set of Laws

- Financial Administration
- •Election
- Disclosure and Transparency
- Privacy Protection
- Appointments of non-elected positions

# Why aren't social programs in the basic set of laws?

- The FSGA lists TGG's jurisdictions over areas of social programs such as adoption, income support, education, social housing, etc.
- The reason why these types of social programs are not in the basic set of laws is because our elected government will need to ensure it has the capacity to take on such important programs.
- Until then, these programs will continue to be provided by the Government of the Northwest Territories (GNWT).
- Once TGG has the basic set of law to operate as a government, it can consider what other laws, including social programs, might be enacted under the FSGA to benefit the Tłegohłį Got'įnę.

- Even during the one-year transition period, if the basic set of laws has been worked out and is ready to be enacted on the Effective Date, (hopefully April 1, 2026), nothing stops TGG Inc from starting to consider what other laws might be enacted to benefit the Tłegohłį Got'įnę.
- Examples of such programs that have already been discussed that would benefit Tłegohłį Got'įnę citizens regardless where they live, include:
  - Lowering the elder's assistance age (from 60 years old to 55 years old)
  - Low Income and Living Standards Assistance in:
    - Utility expenses
    - Grocery expenses
    - Childcare expenses
  - Sports and Culture Assistance (e.g. sports equipment for kids)
  - the availability of home renovation and maintenance programs to every TGG household across Canada

## How will the Transition Year be Funded?

#### **One-Time Start-up Funding**



One-Time Start-Up Funding is a **one-time grant payment** to support activities associated with a group's transition to self-government.

One-Time Start-Up funding targets key areas such as, but not limited to:


- Development of core laws;
- Setting up new governance and administration systems;
- · Communications and consultation; and
- Transition-related training for staff.

The amount of funding is determined by the work needed to be done by a group to prepare for effective date. This includes community meetings, existing staff training, incremental office space and equipment and other start-up activities.



One-Time Start-Up Funding is transferred following a successful community ratification up until the Effective Date of the agreement, at which point Ongoing Governance and Administration Funding begins.

# First Election of the Legislative Council

- There are currently 8 directors on the board (and 1 vacancy). On the effective date, these directors will become the legislative council.
- The first election for the legislation council must take place within 2 years of the effective date.
- We will elect 4 councillors and a president for a 4-year term and we will elect 4 more councillors for a 2-year term. After that, there will be an election every 2 years for 4-year terms.

# Participation by Non-Residents

- Currently non-residents cannot be on the board of directors.
- Under the Constitution, 4 of the 9 legislative councillors could be non-residents.
- All Tłegohłį Got'įnę, resident and non-residents, will be Citizens on effective date.

# What kind/type of Self-Government will you be voting for?

- As a Citizen you will cast a vote for the President and for each of the 8 other Council positions in staggered elections held every 2 years under the Constitution.
- Under the Constitution the President must be a resident of Norman Wells; but up to 4 of the 8 councillors could be nonresidents.
- Council can then make appointments to non-elected positions within the Government.

## How can I participate in Self-Government?

- Regardless where you live in Canada, under the proposed Constitution, you can run for a seat on your Legislative Council
- Regardless where you live in Canada, you may be the best candidate for appointment to the Institutions that the Legislative Council may establish to provide programs or services or to represent your Self-Government in negotiations with other governments.

# What will I be voting on? Two Things

### • The Final Self-Government Agreement for the Tłegóhłį Got'înê

- Like the Land Claim Agreement it will be a constitutionally protected treaty
- See the Summary of the Final Self-Government Agreement
- Can only be amended by agreement between you and Canada and the Government of the Northwest Territories

## • The Tłegółłį Got'înê Government Constitution

- This is your Self-Government's Constitution governing how your Self-Government will exercise the jurisdictions and authorities set out in the Final Self-Government Agreement
- You can amend the Constitution without asking or requiring the consent of Canada or the Government of the Northwest Territories

#### Both Documents must be Approved by you in the Ratification Vote.

If you want your voice to be heard, and if you want to make a difference, you need to cast your vote.

50% plus 1 of you must vote and of the votes cast, 50% plus 1 must be in favour of both documents.

## **Recent Questions Received by Email**

- Frequently Asked Questions (FAQ) are posted on TGG Vote.ca and the FAQ posted have been updated after each Information Meeting and after emails received directly or sent to the Chief Ratification Officer.
- Some of the more recent questions received by email are:
  - Why can't members get emails and phone numbers for all of you when they ask for TGG Inc's membership list?
  - Why can't Ratification be paused to negotiate a perfect FSGA?
  - Why can't Ratification be paused so the FSGA can include mental health support, housing assistance, food subsidies and other social programs?
  - What's happened to our money?

Why can't members get emails and phone numbers for all of you when they ask for TGG Inc's membership list?

#### Answer:

As a Not-for Profit Corporation governed by the Canada Not-for-profit Corporations Act and its Regulations, TGG Inc. has a duty to protect the privacy of the personal information of its Members, Employees and Contractors; just like Canadian governments have a duty to protect your personal information.

The Act and its Regulations make an express exception to this duty to protect your privacy by requiring TGG Inc to keep a membership list that contains your names and mailing addresses. The Act requires that TGG Inc give its membership list to a member who (1) asks for it and who also (2) swears that she will only use the information for corporate purposes.

TGG Inc cannot give any of your other personal information to anyone, not even a family members, without your consent.

## Why can't Ratification be paused to negotiate a perfect FSGA?

#### Answer:

The FSGA being voted on has been negotiated over the last 17 or so years. We have negotiated with a Conservative and a Liberal federal government and with changing governments in Yellowknife. All issues were the subject of negotiations – very few provisions were quickly accepted by all three parties.

The basic structure of the FSGA, the structure of the Tłegohłį Got'įnę Government, its jurisdictions as a Exclusive Indigenous Government under Part II and its jurisdictions as a Public Indigenous Government under Part III were negotiated by our team lead by Larry Tourangeau between 2007 and 2020.

Since 2020, lead by Ethel Blondin Andrew, our team has negotiated a new Fiscal Relationship Chapter, an overhauled Tax Chapter, a revised Settlement Lands Chapter and a new Amendment Chapter. GNWT has dropped its earlier insistence on having oversight over TGG's social envelope Jurisdictions using GNWT's "Core Principles and Objectives ("CPOs")". Canada has also dropped its insistence on denying the Tłegohłį Got'įnę who are also status Indians their rights under section 87 of the Indian Act. This FSGA is not a static agreement. It is an evolutionary, living document.

The new amendment Chapter expressly requires good faith negotiations between Canada, the GNWT and TGG <u>every ten years</u> to amend and update the FSGA.

The new amendment Chapter also provides that the FSGA can be amended by mutual agreement between us and Canada and the GNWT anytime before the first 10-year negotiations and at any time between 10-year negotiations thereafter.

If we paused now, before Ratification there is no guarantee:

- when we would get back to the negotiation table with Canada and GNWT.
- that the future federal or territorial governments will be as accommodating as they have been.
- that we would continue to get self-government negotiation support funding because all parties agreed last November that we have finished negotiating.

# Why can't Ratification be paused so the FSGA can include mental health support, housing assistance, food subsidies and other social programs?

- This self-government agreement <u>already</u> recognizes that our Indigenous self-government, the Tłegohłį Got'įnę Government, has the power and authority to create and provide, either by itself or by working together with other Canadian governments, social programs.
- The Constitution (section 9) provides that the Tłegohłį Got'įnę Government must exercise "all powers and authorities in a manner consistent with Dene Law [as defined in section 3]", the Constitution and Tłegohłį Got'įnę Law; and "at all times, act fairly and without discrimination against, or abuse of, any individual."
- If we put details specifying when, how and what specific social programs shall be provided to the Tłegohłį Got'įnę into the FSGA we would need Canada's and GNWT's approval to make any changes to those social programs.
- Under this self-government the Tłegohłį Got'įnę Government can be changed any of its social programs to meet changing and new circumstances without having to seek Canada's and the GNWT's agreement.

### What's happens to our money?

- The money that your current and previous Boards of Directors spend on you through programs and services ("Our Own Money") is the money in the Norman Wells Financial Corporation (NWFC").
- NWFC's only sources of revenue is the Sahtu Trust and "other revenue", the interest it earns on the trust moneys on deposit in the bank.
- NWFC will not become part of TGG. It will continue to operation as a separate entity holding "Our Own Money" in trust until it can be spent on "permitted purposes" listed in Chapter 11, like Elders Payments, Scholarship Medical Emergencies, Bereavement, and "Christmas Turkey".
- NWFC has no employees, so it gives Our Own Money to TGG Inc under a "contribution agreement" to fund the programs and services you receive as "permitted activities" and to off-set TGG Inc's administration expenses.

# What about the money at TGG Inc (NWLC)?

- 95% of TGG Inc's (NWLC's) money is from either the Government of Canada or the GNWT under contribution agreement, or from SSI and NWFC for designated purposes.
- This is not "Our Own Money" for TGG Inc to do with as it pleases.
- Under the contribution agreements with Canada and GNWT those governments money <u>must be used</u> to deliver those governments programs and services for purposes those governments have specified to the people those governments have identified within the Sahtu and to subsidize our administration expenses in delivering those GNWT and Canada programs.
- Under the agreements with SSI the money <u>must be used</u> for such designated purposes.
- Under the agreement with NWFC the money <u>must be used</u> for "permitted activities" under the Land Claim.
- These moneys cannot be reallocated and used on TGG Inc's own programs and services.

#### NGO Stabilization Fund - CONTRIBUTION AGREEMENT

#### APPLICATION GUIDE for 2024-2025

#### Mandate

The NGO Stabilization Fund is an application-based contribution agreement program that provides special funding to non-governmental organizations (NGO) who deliver critical GNWT funded programs or services to the public to stabilize or develop their capacity to manage programs and services.

Contributions to stabilize and assist these NGOs with management, governance, organizational development and extraordinary operations costs may be made to NGOs based on their application for such funding.

#### Eligibility

- Eligible NGOs are those which:
  - a) Deliver critical GNWT-funded programs or services to NWT Residents,
  - b) Receive annual funding from the GNWT for the delivery of those critical services or programs and be in compliance with existing funding agreements,
  - c) Be registered and in good standing in the NWT either as a society or association or as created under NWT or Federal statute
- Support can be granted for eligible one-time general costs including:
  - a) General management costs that cannot be attributed to specific programs or services.
    - Examples are general administration and management, finances and book keeping.
  - b) Governance costs or board related costs. Examples are governance and board training.
  - c) Organizational development costs related to the structure and processes of the

organization.

Examples are communications, structure, roles and responsibilities.

### What about expenses?

- TGG Inc has not run a deficit (net loss) since the early 2010's
- All Our Own Money is still in the NWFC, unless it has been used for "permitted activities" under Chapter 11 of the Land Claim.
- 95% of TGG Inc's activities, including self-government expenditures are paid for by GNWT or Canada under the contribution agreements with those governments. They are not paid for using Our Own Money.
- Canada and GNWT also require TGG to submit reports and financial audits every single year to ensure compliance with the contribution agreements.
